10. CORRESPONDENCE – The Clerk reported on items received, in December 2020 and early January, 2021 as previously circulated to the Chairman and Councillors. Correspondence to note: Applications invited for the Making A Difference Grant via Hambleton District Council, Defibrillator Alert re Nosterfield. YLCA Training programme, as well as to note the increase in correspondence due to Covid 19 pandemic.

#### 11. PLANNING AND DEVELOPMENT

11.1 Consultation on the following planning applications:

Construction of single storey rear extension to 5 Church Street, West Tanfield,  $HG4\ 5JQ\ -\ 20/02772/FUL$  and listed building application 20/02773/LBC

It was agreed the Parish Council has no objections.

Outline application (some matters reserved) for the construction of 5 No detached dwellings on land Thornfield Road, Thornfield Road, Nosterfield, North Yorkshire -20/02791/OUT

It was agreed the Parish Council would submit the following points to Hambleton District Council:

- 1. Access onto the B6267. Although we note the revised proposed arrangements are better than those that preceded it we are still concerned that traffic moving to the East (at a current 40mph limit) would have a relatively small time to react to vehicles exiting the proposed development.
- 2. We are concerned that there will not be enough parking within the development for residents and visitors
- 3. We want to see fully developed plans for parking for the existing residents along the B6267
- 4. Despite Yorkshire Water's reassurances we are concerned that this development and the others either side of the B6267 will cumulatively put too much pressure on an infrastructure that YW have said needs improvement.
- 5. Finally if allowed, this development would be likely to attract families with children. The proposed green area in front of the houses will inevitably draw them to cross the B6267 to the play area on the south side. We do not believe the development should be allowed unless the speed limit through the village is reduced to 30mph or below.
- 11.2 Updates and decisions on applications, appeals and enforcement investigations received since the last meeting.

  Alterations to existing dwelling to include replacement of existing timber windows and doors, re-building existing chimneys, re-lay and raise existing roof, addition of 2no Georgian style dormer windows and conservation rooflights, replacement of 2no windows within modern (2014) extension with glazed heritage door sets, internal alterations to include loft rooms, attic space and re-located kitchen and living spaces Village Farm, Nosterfield, North Yorkshire, DL8 2QX 20/02398/FUL and Listed Building application 20/02391/LBC Granted
